Day 1 | Depart New York City, NY | 4pm

Arrive at the New York City pier and embark on the Norwegian Breakaway.

Day 4 | Puerto Plata, Dominican Republic | 10am – 6pm

Puerto Plata is the ninth largest city in the Dominican Republic, and the capital of the province. For spectacular city views, take a ride up the Pico Isabel de Torres mountain which stands over 2,600 feet high. History buff? Visit Fortaleza San Felipe, which was built in the 16th century and served as a prison under the dictatorship of Rafael Trujillo. Or head to the Amber Museum, a museum filled with a unique collection of valuable Dominican amber, which is tree sap that has hardened for millions of years capturing many fossils of plant and insect life.
